- 2. Goods and/or services to be purchased: 18in Spiral Wound PVC Pipe and two manhole rehabilitations
- 3. Estimated total dollar amount of expenditures pursuant to this request: \$142,625.29

This is a one-time sole source purchase, to be completed within the next fiscal year.

 - a. Brief description of the purpose of the goods or services to be purchased: The purpose of the goods and services are to rehabilitate a corroding 18in SAS DIP under a major road (San Mateo Blvd); this pipe segment needs to be rehabbed prior to another planned SAS Re-Direct project, because this piping will likely be surcharged, and surcharging would likely cause failure in its current condition.

During the system design process, several alternatives were evaluated and the current proprietary process was selected; AUI is the only on-call contractor capable of installing spiral wound PVC pipe they are the licensed Spiral-Wound contractor for NM. For the rehab of this SAS segment underneath San Mateo, the installation of spiral wound pipe does not require a full bypass setup and allows a manageable amount of flow to pass while the spiral-wound liner is installed, which drastically decreases public impact, and does not require a full bypass set up, which would require a full closure of San Mateo Blvd, and would substantially increase the project cost and construction timeline.

This purchase will rehabilitate and renew a corroded 18in SAS DIP. If the corroded DIP remains unrehabilitated the risk of a pipe failure or collapse is more likely. The 18in DIP is crossing a major arterial road at San Mateo Blvd SE and Coal Ave SE near a Walmart. Rehab of this SAS pipe segment is necessary as a first step, so that a future redirect project can relieve an existing over-capacity SAS line on the northside of Central Avenue. This project will minimize the chances of future sanitary sewer overflows (SSO)s, which will be a direct benefit to our ratepayers, and minimize the chances of sewage backing up into homes/businesses. As previously indicated, rehab of this line with a Spiral-wound liner does not require a full bypass across San Mateo, and thus does not require a temporary road closure of San Mateo Blvd. either. The proposed solesource rehab technique will save both time and money, and minimize traffic impacts to the public and our ratepayers.
