Thank you for your continued interest in Evoqua Water Technologies LLC. Evoqua would like to extend the existing contract to provide services and equipment to the San Juan Chama WTP.

Per our conversation, the cost of repair parts and labor has increased over the past year so a price increase is necessary. If agreeable, the price for Equipment and Routine Services will now be \$9,500 per month with an estimated annual total being \$114,000. Pricing shall remain valid March 1, 2025 through February 28, 2026. Monthly Fee includes the rental of all equipment listed in original contract, Q191213MFM1, as well as a monthly maintenance visit. A billing cycle for rentals consist of four (4) weeks or 28 days. The \$5,000 Demobilization Fee, listed in the original contract, includes all labor and equipment required to demobilize the chemical feed and storage equipment.

All services and equipment shall remain unchanged per the original proposal Q191213MFM1. The Terms & Conditions of the existing contract shall apply (Q191213MFM1). Pricing does not include any applicable taxes.
