a. Brief description of the purpose of the goods or services to be purchased: The NO-DES unit is a cab and chassis equipped with a skid mounted flushing system. The skid unit has filtration vessels between suction and discharge connections to capture sediment for removal and disposal. The skid mounted unit includes an operator terminal with pressure gauges, turbidimeters, emergency shut-off switch, bubble traps and truck engine controls and monitoring.
